Member's Clubhouse Use Agreement**

_____ I agree to follow the **House Rules** and to obey the regulations listed below. I understand it is **my responsibility to notify my guests of such rules and encourage them to abide by them since I am responsible for their behavior and demeanor while at the LGYC Facility.** In this agreement "**LGYC Facility**" or "**facility**" includes the entire clubhouse and parking area.

_____ I understand that **I, as an LGYC member, must be present** during the entire event including set-up and clean-up times. **I will not give clubhouse keys or key-lock combinations to any non-LGYC guest.**

_____ I understand a \$100.00 cleaning and security deposit is required to reserve the facility. The deposit must be tendered at the time the reservation is made and will be returned upon approval of the condition of the facility after use.

_____ I understand that the set-up and clean-up is my responsibility and **I agree to leave the facility in the same condition** as when my use began. The LGYC Facility is to be cleaned by noon the day following my event. Failure to do so will result in the **loss of my cleaning deposit.**

_____ Children must remain with a parent, legal guardian or other supervising adult at all times.

_____ Music (either by Disc Jockey, live band or stereo) will play only during the event time and must be **approved in advance** by the Rear Commodore. Music and other noise **must end no later than 9 PM Sunday through Thursday and 10 PM on Friday or Saturday.**

_____ **Alcohol** must remain inside the facility or parking lot area at all times. **I, as an LGYC member,** am responsible to see that adequate liability insurance is in effect and that any required **Alcohol and Beverage Commission (ABC) permits** are obtained and available during the event, with a copy given to the LGYC Bridge prior to the event..

_____ I have read and understand the following additional rules:

- **No pets**, except service animals, are allowed in the clubhouse or adjoining parking lot
- Use of the clubhouse does **NOT include access to Member's or Club liquor**, beverages or supplies of any kind found within the clubhouse.
- The **Bar-B-Que** may be used with prior permission **in accordance to the written instructions** posted in the **facility.**
- All **personal items** brought by party hosts or guests **must be removed including trash and refrigerator items.**
- **Tables and chairs**, etc. must be **wiped down and put back** in their original position when done.
- **Smoking is not permitted** inside the facility at any time. A designated smoking area is available at the rear of the facility.
- **All decorations must be taken down.** Balloons are to be popped and removed.
- The **number of guests** at any event **will not exceed 80.**

If I, or any of my guests, breach this agreement and/or any County Ordinances, then I may forfeit the deposit and incur additional fees which may be imposed by the Lake Gregory Yacht Club, and/or relinquish my reservation of the facility.
